HEREBY DECIDES AS FOLLOWS:

academic supervision of the Ministry of Higher Education, for the academic year 2025/2026;

Article 1:: (1) For the 2025/2026 academic year, a competitive entrance examination is organised for the selection of three hundred and fifty (350) students in the first year of the "Higher Business Studies" Programme into the Higher Institute for Training in Telecommunications, Technological Innovation, Commerce and Management (IFTICSUP) and into the Yaoundé Higher School of Economics and Management (YSEM), Private Institutes of Higher Education under the academic supervision of the University of Douala and under the technical supervision of ASEB.

The training is full-time (day classes) and the distribution of places is as follows:

IFTICSUP - Yaoundé	YSEM - Yaoundé

- (2) In the context of recruitment, it should be noted that:
- (a) Yaoundé Higher School of Economics and Management (YSEM) will provide training exclusively in Managerial Specialties (Marketing, International Trade and Supply Chain Management, Human Resource Management)
- (b) Institute for Training in Telecommunications, Technological Innovation, Commerce and Management (IFTICSUP) will provide training exclusively in Fnancial and Accounting Specialties (Accounting, Finance and Auditing; Economic and Financial Engineering)

Article 2: The examination is opened to male and female candidates who hold a Baccalauréat (A, B, C, D; TI or G) or GCE Advanced Level with Mathematics and/or Economics and Management related subjects.

Article 3: Candidates application files include the following:

- 1. An application form downloadable at: https://essec-dla.com/concours (also available at ASEB, IFTICSUP and YSEM admission offices);
- 2. A hand-written application bearing a CFAF 1,500 fiscal stamp;
- 3. A certified true copy of birth certificate issued not more than three (3) months ago;
- 4. A certified true copy of the Baccalauréat or GCE A/L;
- 5. Certified true copies of the first and second terms transcripts of "Terminale" or Upper 6th for candidates applying before their Baccalauréat or GCE A/L examination results are published;
- 6. A medical certificate issued not more than three (3) months ago by a State registered medical practitioner;
- 7. Two (2) recent passport size photographs of the candidate;
- 8. An authorization to register for the competitive examination issued by the Ministry of Public Service and Administrative Reform, or the competent Administrative Authority, for civil servants and state agents;
- 9. A receipt issued upon payment of CFAF 20,000 (twenty thousand francs) in the following account: École Supérieure des Sciences Économiques et Commerciales (ESSEC), n° 14004000005, United Bank for Africa (UBA) Cameroon, (NB: the payment should strictly be made under the candidate's name);
- 10. An A4 self-addressed envelope bearing a CFAF 1,000 postal stamp.
- Article 4: (1) Once the above application files are compiled, the admission certificate (or second term transcript), the certified photocopy of the birth certificate, a passport size photo and the payment receipt must be scanned in colour and uploaded on the online registration platform (https://essec-dla.com/concours) after having properly filled all the requested information, latest on Friday, September 12 2025 at midnight.
- (2) Only candidates who will have fulfilled this online registration of their application shall be authorised to sit for the examination. This requirement also applies to foreign CEMAC candidates and all applicants must note that access to this online registration will no longer be possible after the deadline.
- (3) The complete application files (hard copy) shall be submitted at the admission office of ASEB, IFTICSUP, and YSEM or sent to ASEB postal address (P.O. Box 1931 Douala Cameroon), latest on Monday, September 15, 2025, as evidenced by postmark.
- Article 5:(1) The competitive entrance examination shall take place on Wednesday, September 17, 2025, starting at 8 am sharp, potentially in the following examination centres: Douala, Yaounde, Bafoussam, Garoua and Buea. To access the examinations rooms, the national identity card and the online registration receipt (to be downloaded and printed) shall be required to the candidates.
- (2) Applicants from centres with less than 100 applications may be grouped with a nearby centre. Centres may also be created in regions with more than 100 applicants. If applicable, the information relating to this, as well as the examination location, will be indicated on the ASEB website, latest one week prior to the examination.

Article 6: For Cameroonians and foreign applicants who are not CEMAC nationals, the competitive entrance examination has only one part, a written examination representing 100% of the final mark. Subjects will be available in French and English and it is up to candidates to choose any of both languages.

Article 7: The examination comprises the following three (03) papers of equivalent importance:

1.	General Mathematics	"Terminales scientifiques" and upper 6th programmes	02 hours
2.	Specialised Mathematics	Combinaison of probability and financial mathematics. Upper 6 th Science and "terminales des enseignements général et technique commerciale" programmes	02 hours
3.	Economic Essay	On an economic subject to test the candidate's interest in economics or management topics relating to contemporary firms preoccupations, current national and international economic problem or to recent economic history or geography	02 hours

Article 8: With respect to communitarian agreements, 10% of the places open to Cameroonians are awarded on the basis of merit to foreign candidates who are nationals of the CEMAC zone. These places shall be shared among these countries, based on the criterion of merit, in proportion of the number of candidates originating from each of them.

Article 9: The Rector of the University of Douala, the President of the Board of Directors of IFTICSUP, the President of the Board of Directors of YSEM, the Director of University Accreditations and Quality of Higher Education and the Director of ASEB Douala shall be responsible, each in his/her own sphere, for the implementation of this decision which shall be registered and published wherever necessary.
